Changes in the Management Board of Ryvu Therapeutics S.A.

The Management Board of Ryvu Therapeutics S.A., with its registered office in Kraków (the "Company", "Ryvu"), hereby informs that on May 27, 2025, the Supervisory Board of the Company, acting pursuant to Article 368 § 4 of the Polish Commercial Companies Code (k.s.h.), appointed Ms. Justyna Żółtek to the Management Board of the Company, effective as of June 1, 2025.

Ms. Justyna Żółtek joined the Company in 2021 and, since May 2024, has served as Chief People Officer. She is responsible for the Administration and HR functions, including all employee development processes and the Company's internal culture.

Information regarding Ms. Żółtek's education, qualifications, previously held positions, and professional experience has been attached to this Report. Justyna Żółtek

Justyna Żółtek dołączyła do Spółki w 2021 roku jako Dyrektor HR, obejmując odpowiedzialność za utworzenie i rozwój funkcji personalnej w Ryvu Therapeutics. Od maja 2024 roku pełni funkcję Chief People Officer, odpowiadając za obszary Administracji, Kadr i Płac oraz HR.

W trakcie swojej pracy w Spółce opracowała i wdrożyła kompleksową strategię zarządzania kapitałem ludzkim, zbudowała zespół HR oraz wprowadziła kluczowe procesy w zakresie rozwoju przywództwa, zarządzania talentami oraz transformacji kultury organizacyjnej.
